

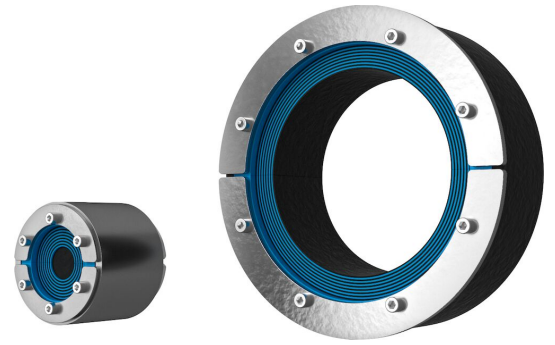


# Vedação Roxtec RS com SL RS
