

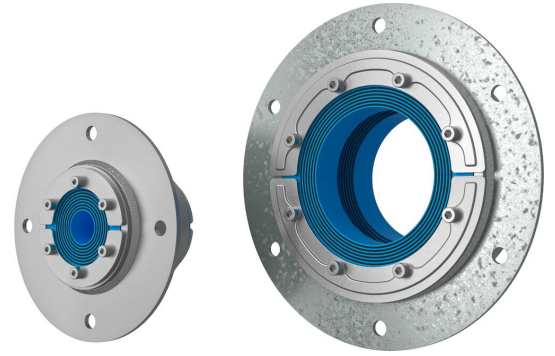


Roxtec RS PPS/S -tiiviste ja SLF RS

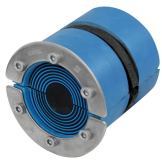
