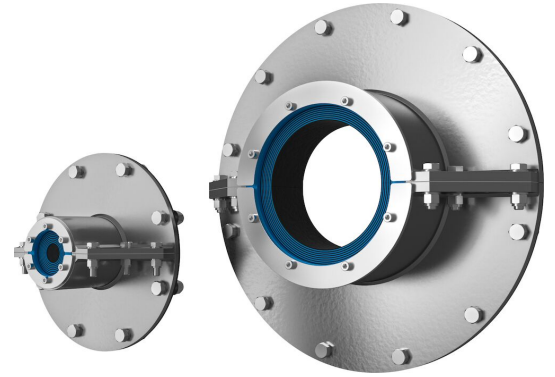




# Roxtec RS afdichting met SLFO/RI

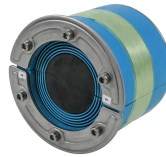
