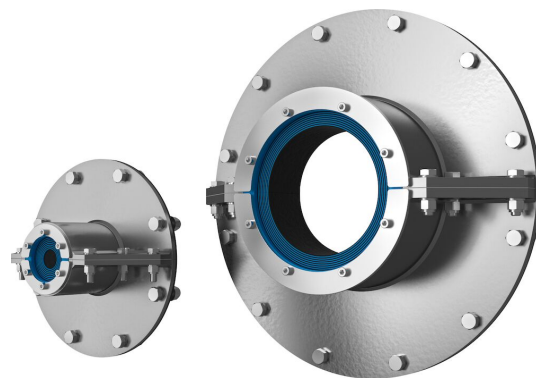




Vedação Roxtec RS com SLFO/RI

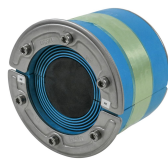
