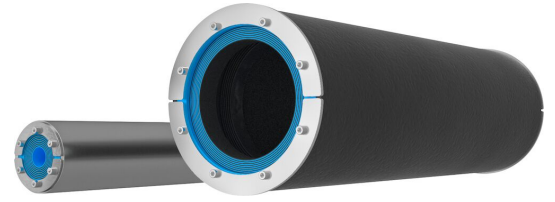




Sello Roxtec RS PPS/S F+WT con SL PPS

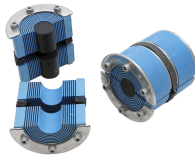
