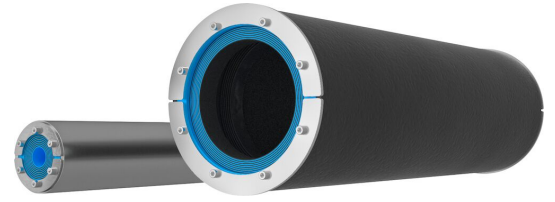




Bague Roxtec RS PPS/S F+WT avec SL PPS

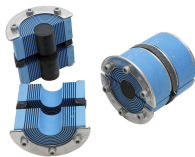
