




Roxtec WaveGuide Seal ES (Welded)

It is a high-performance product, based on a waveguide technique, offering minimum 100dB shielding effectiveness. This version is for welding to the structure. The sealing modules can be adapted to different sizes of fiber optic cables and can also be used to build in spare capacity in the transit.
