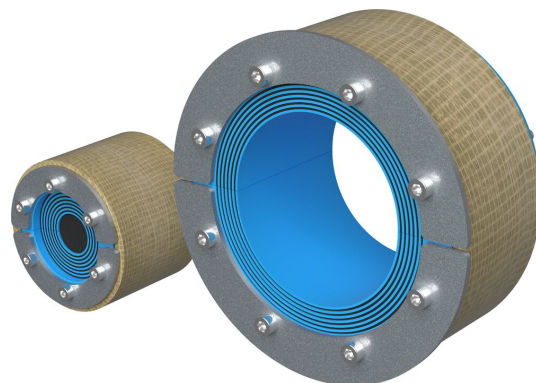




Uszczelnienie Roxtec RS z SL GRP
