

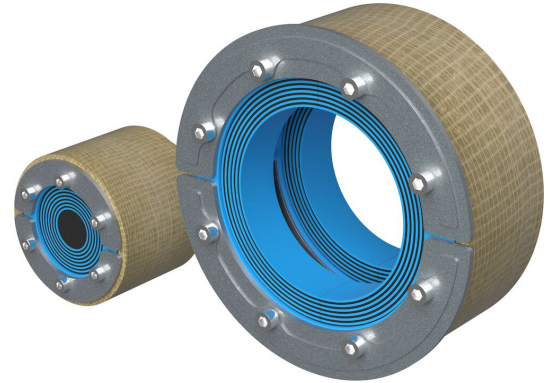


# Roxtec RS PPS/S afdichting met SL GRP

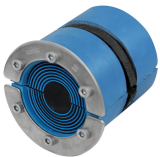
