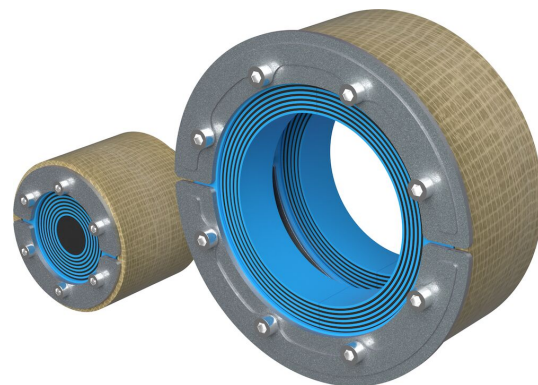




# Roxtec RS PPS/S-tätning med SL GRP

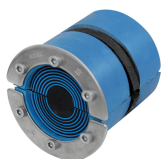
