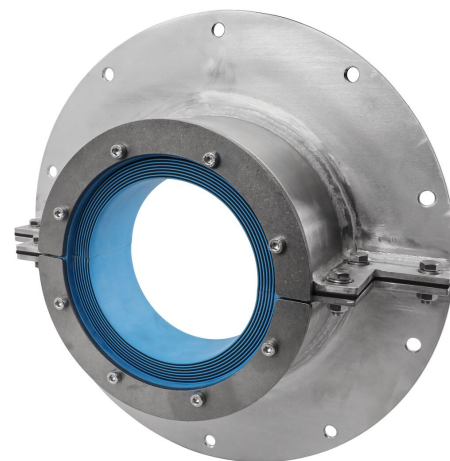




Joint Roxtec RS avec SLFO/Ext

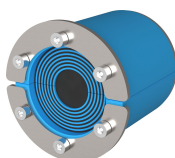

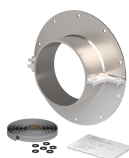
