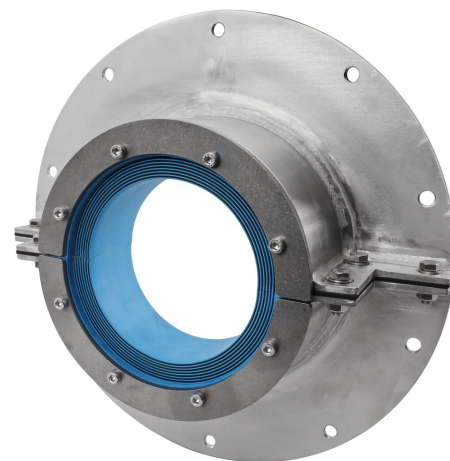




# Roxtec RS-tetning med SLFO/Ext

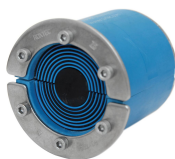
